2. Secretary (Housing & Works) stated that the meeting was called at short notice to discuss the situation which arose after verification of the declarations submitted by the applicants of categories I and II houses from the Establishment Division. He informed the members of the Committee that previously he had sent only 10% of the cases of categories I & II houses for verification, but in view of certain noticeable discrepancies, it would be necessary of categories I & II cases that the entire list made out on merit basis be got verified from the respective offices of potential allottees. The members of the Committee were informed that the records of the following applicants of Category I & II did not tally with their declarations and thereby did not meet the criteria laid down for according priority in allotments. Therefore, their names should be deleted from the list of higher priority candidates of categories I & II houses under phase I of the scheme.

- b. The offer letters may be got printed from the Printing Corporation of Pakistan in accordance with the format approved by the Committee (copy attached).
- c. The declarations of the applicants belonging to service groups other than All Pakistan Unified Grades may be got checked/verified from the concerned Ministries/Divisions.
